

### **Terms and conditions**

#### Language:

The Company may provide a translation of the English version of the terms into other languages, and the purpose of any translation of the terms into another language is for easy viewing only, but the Arabic version governs the terms of your relationship with the Company. Furthermore, if there are inconsistencies between the English version of the terms and any translation thereof, reference shall be made to the Arabic version first.

### **Conditions:**

1. When the tenant agrees to these terms, he acknowledges that he is bound by all of their terms.

2. The tenant acknowledges that he is fully aware that the company does not bear any responsibility towards any party when any injury occurs inside or outside the facility.

3. The tenant acknowledges that he is fully aware that the company does not bear any responsibility towards any party in the event of losing any of his property on the courts and its accessories, and that he is solely responsible for maintaining his property.

4. The tenant must provide a copy of the passport or ID when registering in the electronic application

5. Requests and reservations are not confirmed until the official registration and payment of fees.

6. Fees and expenses paid are non-refundable and cannot be deferred or transferred in the name of another person.

7. The tenant bears any damages or injuries caused to the players while they are on the court, and the company does not bear any responsibility for injuries or death, God forbid.

8. The tenant shall bear the cost of any damage or damage to the property of the facility or its participants, that may arise due to his act.

9. The company is not responsible for injuries, theft, quarrels, or infringement by third parties that may occur while renting the court or using the club's facilities, and the tenant is responsible for himself and those with him.

10. The tenant undertakes not to use the preserve in a way that violates public morals, otherwise the contract will be immediately rescinded, and he must pay the full value of the court rental with the items in case they are not returned, and the company has the right to inform the competent authorities if necessary.

11. The tenant is not allowed to train with any coach outside the club's

13. In the event of cancellation or postponement of the reservation, the tenant must inform the company about that 24 hours before the time of the reservation for cancellation or any modification of the reservation.

14. The tenant is not allowed to place banners or billboards without the company's approval

15. The tenant acknowledges that he has read and agreed to all terms.

16. The tenant must abide by the time specified for him and is not allowed to infringe on the timing of other reservations after it.

17. It is forbidden to eat hot food and drinks (tea or coffee) inside the courts.
